From individual to collective action: which role for sea basin initiatives to strengthen Ocean Literacy in Europe?

The main objective of the workshop is to demonstrate that ocean literacy is everybody's individual and collective responsibility from the local to the sea basin scale. Building on illustrations of ocean literacy activities carried out by individual (maritime) sectors and groups of stakeholders at different territorial scales, it then discusses how collective action could be organised at the sea basin scale to strengthen ocean literacy in Europe. In particular, it identifies the role of, and the conditions (e.g. in terms of knowledge, capacity, governance, policy, financing....) that would need to be set at, the scale of sea basins to support the upscaling of ocean literacy in Europe.

The workshop (see agenda below) combines speeches and presentations, panel discussions as well as interactive exchanges mobilising the experience and views from all workshop's participants.
