Rupi e castagneti secolari ospitano fauna importante (Gufo reale); le acque limpide del Rio Tassaro ospitano una delle ultime popolazioni di Gambero di fiume del reggiano; pinete relitte tra le più estese di Pino silvestre autoctono; la più vasta sorgente pietrificante con formazione di tufo del reggiano
