### Other Site Characteristics

Dalle dune relitte coperte di boscaglia termofila e con pratelli aridi di colonizzazione delle sabbie consolidate, alternate a coltivazioni di cereali e ad incolti, alle pinete di Pinus pinaster di origine antropica, alle dune attiv, ridotte a piccoli lembi dalla costruzione di imponenti scogliere artificiali. Sono inoltre compresi le spiagge e il tratto di mare antistante, per un tratto di circa 250 metri. E' inoltre compresa la foce del fiume Lamone.

### 4.2 Quality and importance

Specie vegetali RARISSIME e MINACCIATE: Trachomitum venetum, Zanichellia palustris subsp. pedicillata, Centaurea spinosa-ciliata subsp. tommasinii. RARE E MINACCIATE: Erianthus ravennae. Specie animali: Paradromius longiceps: specie localizzata, legata ai fragmiteti, soprattutto in zone litoranee. Importante successione di habitat ormai distrutti lungo quasi tutto il litorale adriatico.
