RARE: Helianthemum jonium. Specie animali: le aree prative, di notevole estensione, sono un importante sito di nidificazione di Circus pygargus, Caprimulgus europaeus, Lullula arborea, Anthus campestris. Interessante la presenza di Rhinolophus hipposideros.
